All work in the yard, unless otherwise specified in this agreement, is to be done by the boat owner. The Milwaukee Community Sailing Center, Inc (MCSC) may have staff available to assist the boat owner and to offer advice, if necessary, on a limited basis. The staff of MCSC retains the right to stop any and all work should they deem it to be harmful or dangerous.

Each boat owner is responsible for maintaining their storage area and any other areas that they use in a clean and orderly fashion.

A \$10 per day storage fee will be assessed to any boat owner who does not have their boat out of the yard by the agreed date: May 15. The MCSC is open to an entirely different group of users during the summer months, and it is important to remove the boats on time. In the event that the boat is not removed within thirty (30) days after the end of the term, Owner expressly authorizes MCSC without notice to proceed in any manner satisfactory to MCSC to sell or otherwise dispose of the boat and recover from the proceeds thereof all amounts then due MCSC, including all actual attorneys' fees and costs expended as a result of such holdover, sale or collection efforts of MCSC. All terms and conditions of this agreement apply until such boat is removed or launched.

In consideration of the insurance of agreement, I hereby agree to obey and comply with all of the rules and regulations of the MCSC, the County of Milwaukee and the State of Wisconsin and that failure upon my part to do so shall constitute sufficient cause for revocation of this agreement. I further agree that the MCSC shall not be held liable for any loss or damage by theft, vandalism or otherwise, to the boat or property used or stored therein while using the MCSC facilities.

I agree that neither the MCSC, nor its employees, volunteers, agents, committees, directors or officers shall be liable, or any other person, for any injury or damage to me or my property occurring, or arising out of, or in connection with, any MCSC party or person, weather or sea conditions, hazards of any kind, defects in vessels, rigging or gear, or from any other cause. I hereby release the MCSC from any claim for personal injury, loss, damage or theft.

I HEREBY CERTIFY THAT I HAVE READ AND UNDERSTAND THIS AGREEMENT AND THAT THE STATEMENTS HEREIN ARE TRUE.
